Fees Levied By Institute Of Post Harvest Technology for Consultancy Services in Establishment and Modernization of Postharvest and Agricultural Processing Industry

INTRODUCTION

The Institute of Post Harvest Technology is the apex institution in Sri Lanka, which seeks to improve the postharvest & agro processing industry through research, training, extension, consultancy and other development activities. All consultancy services are directed towards improvement of efficiency and productivity of the local postharvest and agro processing industries.

The consultancy activities of IPHT are mainly conducted on improved post harvest technologies and agro-processing technologies in durables & perishables and other agricultural commodities (paddy & other cereals, pulses, spices, oil crops, field crops, fruits and vegetables). This service includes selection of proper machines, designing of factory layout/process line, design of factory/storage buildings, cost benefit analysis, energy and waste management, quality and safety implementation, environmental protective measures and solving technical problems encountered in the postharvest & agro processing industry.

DISBURSEMENT OF CONSULTANCY CHARGES

After deducting the cost as per the circular of PF-380 (attached) namely travelling, subsistence, material consumed equipment usage charges, field expenses, surveys, meeting, payment to outside consultants & team members and any government taxes, the balance will be disbursed as follows:

- Of the total revenue earned (after deducting all the direct costs), 20% will be retained by IPHT.
- In addition, 10% will be allocated for IPHT to meet the other overhead costs such as utilities and minor laboratory/workshop charges.
- 70% will be paid to the staff directly and indirectly involved. The proportion of distribution will be decided based on the input of each individual to the consultancy service.
